

Ethics statement

The Asia-Pacific Sustainable Development Journal (“Journal”) is bound by the ethics governing the United Nations, based on its core values of integrity, professionalism and respect for diversity, and the values outlined in the Code of Ethics for United Nations Personnel, which include independence, loyalty, impartiality, integrity, accountability and respect for human rights. Declaration of interest

All authors must disclose any financial and personal relationships with other people or organizations that could inappropriately influence (bias) their work. Examples of potential competing interests include grants or other funding, expert testimony, paid consultancies, paid employment, honoraria, patent applications/registrations and stock ownership. Authors must disclose any interests in a specified declaration form (available at the Journal’s website). Authors must also include the declaration of interest in the title page, submitted separately from the article, to maintain double anonymity. If there are no interests to declare then please state: “Declarations of interest: none.” It is important for potential interests to be declared in both places and that the information matches.

Submission declaration and verification

Authors must sign a specific declaration form (available at the Journal’s website) that their work has not been published previously (except in the form of an abstract, a published lecture or academic thesis, or a working paper), that it is not under consideration for publication elsewhere, that its publication is approved by all authors and tacitly or explicitly by the responsible authorities where the work was carried out, and that, if accepted, it will not be published elsewhere in the same form, in English or in any other language, including electronically without the written consent of the United Nations copyright office or the Communications and Knowledge Management Section of ESCAP. To verify compliance, articles may be subject to an appropriate originality checking software.

Use of inclusive language

The United Nations is an inclusive organization and promotes equality, fraternity and diversity. It discourages discrimination based on gender, culture, religion, ethnicity, language or colour. The Journal emphasizes inclusive language acknowledging diversity, conveying respect to all people and being sensitive to differences. Therefore, the content of an article should make no assumptions about the beliefs, orientations or commitments of any reader and must not imply that one individual is superior to another on the grounds of age, gender, race, ethnicity, culture, age, disability or health condition. Furthermore, authors should ensure that writing is free from bias, stereotypes, slang, reference to dominant culture and/or cultural assumptions. The preference of the Journal is gender neutrality by using plural nouns (e.g., “respondents,” “children,” “policymakers”) as default/wherever possible and avoiding the use of “he, she,” or “he/she.” The Journal also recommends avoiding the use of descriptors that refer to personal attributes such as age, gender, race, ethnicity, culture, disability or health condition unless they are relevant and valid in the sense that the article is concerned with them or deals with issues pertaining to them. The Journal further advises against offensive or exclusionary terms such as “master,” “slave,” “blacklist” and “whitelist” unless the article is dealing with such issues.

Peer review integrity

The Journal is committed to peer-review integrity and upholding the highest standards of review. Once the paper has been assessed for suitability by the editor, it will then be double-blind peer reviewed by independent, anonymous expert referees, each delivering at least one report.

Suggesting reviewers

Authors can submit the names and institutional e-mail addresses of several potential reviewers. However, they should not suggest reviewers who are colleagues or who have co-authored or collaborated or supervised during the last three years. Editors should not invite reviewers who have potential competing interests with the authors. Also, reviewers should not include existing members of the Journal's Editorial Board or Advisory Board. In order to provide a broad and balanced assessment of the work and ensure scientific rigor, the authors should suggest diverse candidate reviewers who are located in different countries/regions from the author group. They should also consider other diversity attributes such as gender, race, ethnicity and career stage.

Data integrity/authenticity

Authors are required to submit their research data set to ensure that it is actively peer reviewed, and the results can be replicated by interested researchers. The Journal requires authors to cite underlying or relevant datasets in their manuscript by citing them in the text and including a data reference list before the main list of References List. Data references should include the following elements: author name(s), dataset title, data repository, version (where available), year and global persistent identifier.

Author(s) rights

While individual authors retain copyright of their articles, United Nations is the holder of the Journal's copyright.

Changes to authorship

Authors are expected to consider carefully the list and order of authors before submitting the manuscript and provide the definitive list of authors at the time of the original submission. Any addition, deletion or rearrangement of author names in the authorship list should be made only before the manuscript has been accepted and only if approved by the Editor. To request such a change, the Editor must receive from the corresponding author the reason for the change in author list and written confirmation (e-mail, letter) from all authors that they agree with the addition, removal or rearrangement. In the case of addition or removal of authors, this includes confirmation from the author being added or removed.

Only in exceptional circumstances will the Editor consider the addition, deletion or rearrangement of authors after the manuscript has been accepted. While the Editor considers the request, publication of the manuscript will be suspended. If the manuscript has already been published, any requests approved by the Editor will result in a corrigendum.

Editing

Manuscripts are accepted on the understanding that they may be edited, including copy-edited. However, author's consent will be sought to ensure that the edited version retains the intended message. Editing is only for enhancing readability without changing the content.

Resolution of complaints

Complaints about plagiarism, conflict of interest or any other malpractices, including bias or any form of discrimination will be resolved by following the ethical code of conduct of the United Nations, setting up an independent body of experts, and where appropriate, by following the guidance/flow-charts [of the Committee on Publication Ethics \(COPE\)](#).

Retracting/withdrawing articles

If malpractice or any other violation of ethical standards, such as multiple submission, bogus claims of authorship, plagiarism, fraudulent use of data or the like, are proven against author(s), their article will be retracted/withdrawn to uphold integrity of publications. This will also apply to articles found published elsewhere and authors deliberately made declaration as to their originality and simultaneous non-submission in other journals. In making this decision the editor is guided by policies of Journal's editorial board and constrained by such legal requirements in force regarding libel, copyright infringement and plagiarism.

However, occasionally a retraction will be used to correct inadvertent errors in submission or publication.
